District 27 Proxy Form and Instructions

At the District Council business meeting, each District 27 Club President and Vice-President Education in attendance is entitled to one vote as long as the Club is in good standing. However, if either or both officers cannot attend, they may designate, in writing, any other active member of their club to act as a proxy for their club. No other proxies or versions of this proxy (hardcopy or softcopy) are valid at this meeting, per Article X, Paragraph (d) of the District Administrative Bylaws.

In the event one of these officers does not attend the meeting and has not designated, in writing, an active member of the club to act as his or her proxy, the officer or proxy holder in attendance is deemed to hold the proxy of the other, and may therefore cast two votes at the meeting. This assures that every club is represented by two votes.

In addition, each active District Officer (District Director, Program Quality Director, Club Growth Director, Public Relations Manager, District Administration Manager, District Financial Manager, Division Directors, Area Directors, and Immediate Past District Governor) in attendance is entitled to one vote. District Executive Committee members carrying proxies from their club are allowed up to three votes. All other members are limited to a maximum of two votes each.

Proxies must be signed by either the Club President or Club Vice-President Education. [Proxies \(PDF\)](#) may be submitted via E-Mail to the District 27 Credentials Chair at credentials@d27tm.org or hand-carried and submitted on the day of the District Council Meeting to the Credentials Chair. You will receive an E-Mail confirmation of your proxy submission.
